A Brief report on “One Day Workshop on Revised syllabus of TY B.com in association with University of Mumbai

Aiming to provide an intense and thorough knowledge at undergraduate level for college and university faculty, “One Day Workshop on Revised syllabus of TY B.com Semester VI of Indirect Taxes” for faculties was organized by Department of Commerce and Internal Quality Assurance cell in association with University of Mumbai on 8th December 2018. Speaking on the session, Chairperson and Resource Person Dr. CA. CMA. Sanjay Sonawane, Member – Board of Studies in Accountancy HOD & Associate Professor in Accountancy, Sathaye College, Vile Parle, Mumbai highlighted the changes introduced in the syllabus. He elaborated the needs and expectations of University of Mumbai from faculties as well as students. He gave some informative examples of how unlearning can be used to understand, rectify, and avert the teaching collapses to some extent.
