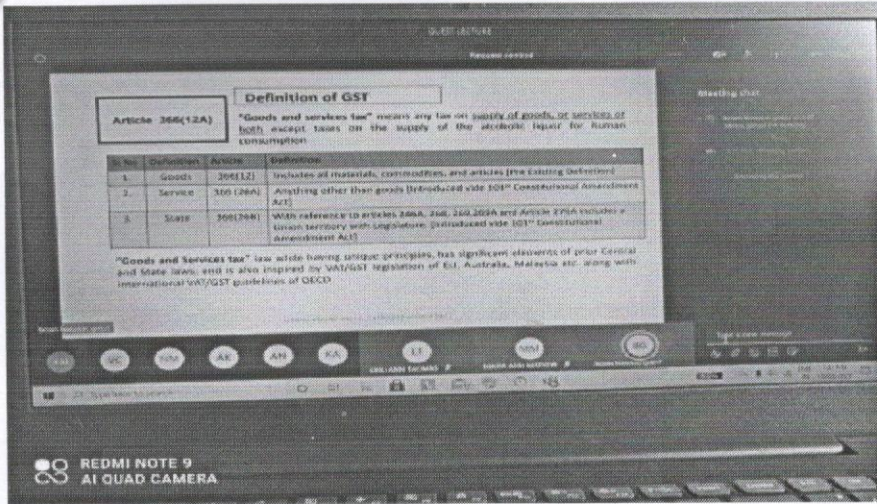
Report on "Understanding GST".

He focused Problems and discussed the solution for the same. He spoke about the laws subsumed under GST and why and also how GST brings in One Nation, One Market, and One Tax. The speaker discussed Rates of GST for different items, how Input Tax Credit works to eliminate cascading and how Valuation of Taxable supply is done and a few sums on the same to give a practical aspect to the workings of GST Law. He covered all the aspects of What is GST and GST Rates. The content was thoroughly explained. The queries were solved.
